The term "On Campus" means any building or property owned or controlled by Phillips Theological Seminary within the same reasonable contiguous geographical area of the institution and used by the institution in direct support of, or in a manner related to, the institution's educational purposes. It also includes property within the same reasonable contiguous geographic area of the institution that is owned by the institution but controlled by another person, is used by students and supports institutional purposes.

"Non-Campus Building or Property" includes any building or property owned or controlled by a student organization such as a fraternity or sorority, recognized by the institution and any building or property owned or controlled by an institution that is used in direct support of, or in relation to, the institution's educational purposes, is used by students and is not within the same reasonable contiguous geographic area of the institution.

"Public Property" is defined as all public property that is within the same reasonably contiguous geographic area of the institution, such as a sidewalk, a street, other thoroughfare, or parking facility, as is adjacent to a facility owned or controlled by the institution, if the facility is used by the institution in direct support of, or in a manner related to the institution's educational purposes.
